Staff Requirements.</b>                      (14) In accordance with KRS 199.896(15) and (16), a staff person with supervisory authority over a child shall complete the following:                      (a) Six (6) hours of cabinet-approved orientation within the first three (3) months of employment;                      (b) Nine (9) hours of cabinet-approved early care and education training within the first year of employment, including one and one-half (1 ½) hours of pediatric abusive head trauma training; and                      (c) Fifteen (15) hours of cabinet-approved early care and education training during each subsequent year of employment, including one and one-half (1 ½) hours of pediatric abusive head trauma training completed once every five (5) years.</p>	
<b>Findings:</b>	
General: Based on review of documentation, a staff member hired 1-12-16, did not complete pediatric abuse head trauma training and completed four (4) of the required nine (9) hours of training for first year of employment. Staff member hired 1-2-08 completed ten (10) of the required fifteen (15) hours of training for the subsequent year of employment.
