General: Based on observation and review of documentation, a caregiver hired on 7/17/21, did not submit background checks through the National Background Check Program (NBCP) portal.

General: Based on observation and review of documentation, the center failed to assure compliance with 922 KAR 2:415E. A staff member hired on 9/9/20, did not have a processed named-based child abuse/neglect check on file and intermittently supervised children alone in the school age room.

General: Based on review of documentation, a caregiver hired on 1/20/05, had TB documentation on file dated that was 5/24/18.

General: Based on review of documentation, a caregiver hired on 12/1/12, lacked four (4) hours of training. A caregiver hired on 7/23/19, lacked nine and one guarter (9.25) hours of training. A caregiver hired on 1/20/05, lacked fifteen (15) hours of training. A caregiver hired on 7/23/19, did not complete six (6) hours of orientation training.

- (6) Medication, including refrigerated medication, shall be:
- (a) Stored in a separate and locked place, out of the reach of a child unless the medication is:
- 1. A first aid supply and is maintained in accordance with subsection (1) of this section;
- 2. Diaper cream, sunscreen, or toothpaste. Diaper cream, sunscreen, or toothpaste shall be inaccessible to a child;
- 3. An epinephrine auto-injector. A licensed child-care center shall comply with KRS 199.8951 and 311.646, including:
- a. An epinephrine auto-injector shall be inaccessible to a child;
- b. A child-care center shall have at least one (1) person onsite who has received training on the administration of an epinephrine auto-injector if the child-care center maintains an epinephrine auto-injector;
 - c. A child-care center shall seek emergency medical care for a child if an auto-injector is administered to the child; and
- d. A child-care center shall report to the child's parent and the cabinet in accordance with 922 KAR 2:090, Section 13(1)(b) if an epinephrine auto-injector is administered to a child: or
- 4. An emergency or rescue medication for a child in care, such as medication to respond to diabetic or asthmatic condition, as prescribed by the child's physician. Emergency or rescue medication shall be inaccessible to a child in care;
- (b) Kept in the original bottle; and
- (c) Properly labeled.
- (7) Medication shall not be given to a child if the medication's expiration date has passed.

Findings:

General: Based on observation, a tube of Calmoseptine Ointment, a tube of Desitin Diaper Cream, and a tube of Baby Orajel each were not labeled to indicate to whom they each belonged to in a purple medication box in the infants' room.

Outdoor Play Area Not In Compliance

(21) A protective surface shall:

- (a) Be provided for outdoor play equipment used to:
- 1. Climb:
- 2. Swing; and

General: Based on observation, a five (5) feet long area of asphalt was under a swing in the outdoor play area. A thin layer of pea gravel was underneath a yellow/red slide and a blue Little Tikes Slide in the outdoor play area.
