General: Based on review of documentation and interview, staff hired on 09/14/19, did not have education verification on file.

General: Based on review of documentation, a staff member, hired on 04/19/21, did not have TB documentation on file.

General: Based on review of documentation and interview, two (2) staff members hired 11/21/19 and 06/10/19, did not complete cabinet approved pediatric abusive head trauma training during the first year of employment.

General: Based on observation, review of documentation and interview, the posted program of activities was dated 2020 and was not followed in the one-year-olds', two-year-olds', and four-year-olds' rooms.

- (a) Be helped with personal care and cleanliness based upon his or her developmental skills;
- (b) Except as established in paragraph (c) of this subsection, wash his or her hands with liquid soap and warm running water:
- 1. a. Upon arrival at the center; or
- b. Within thirty (30) minutes of arrival for school-age children;
- 2. Before and after eating or handling food;
- 3. After toileting or diaper change;
- 4. After handling animals;
- 5. After touching an item or an area of the body soiled with body fluids or wastes; and
- 6. After outdoor or indoor play time; and
- (c) Use hand sanitizer or hand-sanitizing wipes if liquid soap and warm running water are not available in accordance with paragraph (b) of this subsection. The child shall wash the child's hands as soon as practicable once liquid soap and warm running water are available.

Findings:

General: Based on observation, two (2) children did not wash their hands with liquid soap and warm, running water after being diapered in the nursery.

General: Based on observation and interview, soiled pull-ups were stored in an uncovered trash receptacle in the four-year-olds' girls restroom.

Findings:

General: Based on observation and interview, a diaper changing pad had a two (2) inch long tear that exposed foam in the one-year-olds' classroom. In addition, paper, pencils, clipboards and infant shoes were stored on the diaper changing surface. Clip-boards, dirt, pencils, rubber-bands and infant socks were stored on the diaper changing surface in the two-year-olds' classroom.

General: Based on review of documentation and interview, the medication log did not have the name documented of the person who administered Acetaminophen and Tylenol on 09/30/2020, and Clonidine and Risperidone on 06/18/2021.

- (2) Indoor and outdoor equipment shall:
- (a) Be clean, safe, and in good repair;
- (b) Meet the physical, developmental needs, and interests of children of different age groups;
- (c) Be free from sharp points or corners, splinters, protruding nails or bolts, loose or rusty parts, hazardous small parts, lead-based paint, poisonous material, and flaking or chalking paint; and
- (d) Be designed to guard against entrapment or situations that may cause strangulation.

Findings:

General: Based on observation and interview, the door handle was detached from the door of a white Frigidaire Freezer in the kitchen storage room. Rust and chipped paint were on the handlebars of a yellow teeter-totter on the three and four-year-olds' playground. The center's 2006 Chevrolet Express G3500 van was inoperable. An interview determined the van's motor was in need of repair.

General: Based on review of documentation, a child enrolled on 03/25/11, had an immunization certificate on file that was valid until 05/01/21. A child enrolled on 07/13/2020, had an immunization certificate on file that was valid until 11/22/20. In addition, a child enrolled on 08/01/17, had an immunization certificate on file that was valid until 06/17/21.


