## Findings:

General: Based on observation during a tour of the child care center, the surveyor found the following:

- 1. A staff's purse was stored on a shelf in the Preschool room; thus, the purse was within reach and accessible to the children. During interview, staff stated she would have the staff remove the purse from the shelf.
- 2. Liquid hand soap placed in all bathrooms state on the label "Keep Out of Reach of Children"; thus, the liquid hand soap was accessible to the children. During interview, staff stated she was not aware that the liquid soap stated that on the label and they will be replaced as soon as possible.
