Review of children's files on 4/9/19 revealed the immunization certificate presented for review at the time of survey for a child enrolled 5/30/18 was no longer current as of 12/15/18. Interview with staff in charge revealed she needed to obtain a current immunization certificate for the aforementioned child.
