Findings:

General: Based on Review of Documentation and Interview, the childcare center failed to maintain all required background checks. Review of staff files revealed that a volunteer with the hire date of 08/01/2013 did not have a completed background check from Texas. Interview with the volunteer with the hire date of 08/01/2013 revealed that she has lived in Kentucky for four years.
