922 KAR 2:100 - Section 2. Certification Process.

- (9) Within three (3) months of submission to the cabinet of a complete OIG-DRCC-03, an applicant shall:
- (a) Demonstrate completion of six (6) hours of cabinet-approved training in accordance with KRS 199.8982(1)(a)6; and
- (b) Develop and implement a written plan for obtaining nine (9) hours of annual cabinet-approved training as required in Section 10(1) of this administrative regulation.

Findings:

General: Based on review of documentation, this regulatory requirement was not met. A review of the documentation on file found no evidence of a written plan for obtaining nine hours of annual cabinet-approved training.

265 - Provider Training Requirements

Not In Compliance

922 KAR 2:100 - Section 10. Standards for the Provider.

(1)(a) Between July 1 and June 30 of the following calendar year, a provider shall complete at least nine (9) hours of cabinet-approved early care and education training beginning with the second year of operation, including one and one-half (1½) hours of cabinet-approved pediatric abusive head trauma training in accordance with KRS 199.8982(2) to be completed:

- 1. Within the second year of employment or operation in child care; and
- 2. Every subsequent five (5) years of employment or operation in child care.
- (b) A provider or assistant's compliance with the training in accordance with paragraph (a) of this subsection or subsection (8) of this section shall be verified through the cabinet-designed database maintained pursuant to 922 KAR 2:240.

Findings:

General: Based on review of documentation, this regulatory requirement was not met. A review of the Early Care and Education Training Records Information System (ECE-TRIS) website found that the provider had not completed the required nine hours of annual, cabinet-approved child development training.

285 - Television/Video Viewing **Not In Compliance**

922 KAR 2:100 - Section 13. Care Requirements for a Provider.

- (3) Television or video viewing by a child shall be limited to:
- (a) Two (2) hours daily;
- (b) The planned program activities; and
- (c) Developmentally appropriate child-related content, as designated by standardized content guidelines.

General: Based on observation, this regulatory requirement was not met. The surveyor observed HGTV television shows being viewed on the television in the living room, which is the main child-care space, during the entire survey. Eight children were present in the room. The provider confirmed that the HGTV shows being viewed did not include child-related

- (1) A provider shall maintain:
- (a) A current immunization certificate for each child in care within thirty (30) days of the child's enrollment, unless an attending physician or the child's parent objects to the immunization of the child pursuant to KRS 214.036;

Findings:

General: Based on review of documentation, the following was found:

- 1. Three immunization certificates were no longer current as of 9/25/20, 6/8/21, and 7/17/20.
- 2. One child had no immunization certificate on file. The child had been in care for more than 30 days.

General: Based on review of documentation, there was no documentation of quarterly tornado and earthquake drills.

- (5) A certified family child-care home provider shall maintain a written record of:
- (b) Monthly practiced fire drills detailing the date, time, and participants in accordance with Section 12(19) of this administrative regulation;

Findings:

General: Based on review of documentation, there was no documentation of monthly fire drills.

795 - Evacuation Plan Records Not In Compliance

922 KAR 2:100 - Section 19, Records.

(7)(a) A certified family child-care home provider shall have a written evacuation plan in the event of fire, natural disaster, or other threatening situation that may pose a health or safety hazard to a child in care in accordance with KRS 199.895.

General: Based on review of documentation, the emergency preparedness plan on file had not been updated since 4/2/19.

(10)(a) A family child-care home certificate shall:

1. Be displayed in a prominent place, as required by KRS 199.8982(1)(c);

Findings:

General: Based on review of documentation and interview, this regulatory requirement was not met. The surveyor reviewed the provider's bulletin board during the visit and found that the family child care home certificate was not posted. The provider stated that she took it down to make a copy recently and forgot to re-post it. The provider was not able to locate the certificate during the visit.

825 - Posted Documentation Not In Complianc

922 KAR 2:100 - Section 20. Certified Family Child-Care Home Program.

The certified family child-care home provider shall:

- (7) Make available to a parent upon request:
- (a) The staff to child ratios described in Section 10 of this administrative regulation;
- (b) The planned program of activities;
- (c) Each statement of deficiency issued by the cabinet during the current certification period;
- (d) Each plan of correction submitted by the certified family child-care home to the cabinet during the current certification period; and
- (e) Daily schedule including any trips outside the family child-care home;

Findings:

General: Based on review of documentation, this regulatory requirement was not met. The surveyor reviewed the provider's parent bulletin board during the visit and found that the following was not posted:

- 1. Staff to Child ratios
- 2. Daily Schedule

Animals Not In Compliance

830 - Animals Not In Compliance

922 KAR 2:100 - Section 17. Animals.

- (1) An animal shall not be allowed in the presence of a child in care:
- (a) Unless:
- 1. The animal is under the supervision and control of an adult;
- 2. Written parental consent has been obtained; and
- 3. The animal is certified as vaccinated against rabies; or
- (b) Except in accordance with subsection (3) of this section.
- (2) A parent shall be notified in writing if a child has been bitten or scratched by an animal.
- (3) An animal that is considered undomesticated, wild, or exotic shall not be allowed at a certified family child-care home unless the animal is:
- (a) A part of a planned program activity led by an animal specialist affiliated with a zoo or nature conservatory; and
- (b) In accordance with 301 KAR 2:081 and 301 KAR 2:082.

Findings:

General: Based on review of documentation, this regulatory requirement was not met. There was no documentation to verify two indoor dogs were vaccinated for rabies.
