Observation of the volunteer from Stretch'n Grow revealed that five (5) children aged from two to three-year-old were left unsupervised in the Common Area in the preschool building when the volunteer left the five children for approximately two (2) minutes to retrieve a child from the Marvelous Monkey's classroom. Observation of the five (5) children that were left unsupervised revealed that two boys were continously hitting each other on the arms and head while the volunteer was out of the room.

The director could not provide the permission slips for the July 16th field trip for review.

### Findings:

General: Based on Review of Documentation, Interview and Observation, the childcare center failed to obtain all required background checks and assure that copies of the all background checks required were received by the childcare center prior to leaving staff members alone with children. Review of Documentation revealed that the staff members with the following hire dates did not have completed out of state background checks: 12/01/2012 (AZ), 01/10/2014 (IN), 08/08/2014 (WV) and 09/18/2014 (LA). Interview with the staff members without out of state background checks confirmed that the staff members have lived outside of the Commonwealth of Kentucky within the past five (5) years.

Review of documentation revealed that the staff members with the hire dates of 09/08/2014 and 09/09/2014 did not have completed Child Abuse and Neglect (CAN) Checks on file for review, therefore, the childcare director failed to abide by 922 KAR 1:470 by submitting a CAN Check within five days of hire. Continued review of documentation revealed that the staff member with the hire date of 09/08/2014 had a CAN check on file from 2006, and was a previous employee at a center owned by the same director, however, employment was severed and the employee recently returned to the center and an new CAN check was not completed.

Observation of the childcare center revealed that the employees with the hire dates of 12/01/2012, 01/10/2014, 08/08/2014, 09/08/2014 and 09/09/2014 that did not have all the required background checks were alone in classrooms with children for the entire length of the survey on 09/24/2014.

### 305 - Background checks/discharged
