Findings:

General: Based on Review of Documentation, observation and interview, the child care center failed to maintain adequate supervision in accordance with regulatory requirements. Review of records failed to reveal a criminal records check for an employee with the hire date of 9/4/15. Observation revealed said staff person working as the sole caregiver in the Monkey Jungle room with five (5) children at 8:16 a.m.. Interview with the director revealed that the documentation had been misplaced and was not available for review at the time of the inspection.

15 - Activity Areas/Equipment/Materials **In Compliance**

Findings:

General: Based on Observation, the child care center failed to comply with staffing requirements. Observation in the Infant room at 12:01 p.m. revealed one (1) staff person with six (6) children. Interview with staff revealed that the youngest child in the room was ten-months-old and the oldest child was twenty-three-months old. Based on observation and interview the child care center failed to maintain ratios in accordance with regulatory requirements.

 4. Copy of negative tuberculin results or a health professional's statement documenting that the adult is free of tuberculosis. Every two (2) years, the adult shall provide negative tuberculin results or health professional's statement documenting that the adult is free of tuberculosis.
- (b) An address check of the Sex Offender Registry conducted on behalf of the applicant for a Type II child-care center and supporting documentation shall indicate that no individual residing in the household is a registered sex offender.

Findings:

General: Based on Review of Documentation, observation and interview, the child care center director failed to assure compliance with regulatory requirements as it pertains to supervision. Review of staff files failed to reveal a completed criminal records check for an employee with the hire date of 9/4/15. Observation revealed the same individual working alone with five (5) children in the Monkey Jungle room at 8:16 a.m. for an undetermined amount of time. Interview with the director revealed that the documentation had been completed; however was unable to be located at the time of the inspection.

280 - Altered/Falsified Records

- (o) Assure each mandatory record specified in Section 3 of this administrative regulation has not been altered or falsified;

 2. Criminal records check required by KRS 199.896(19);
 3. Criminal records check for any previous state of residence if the person resided outside the state of Kentucky in the last five (5) years; and
 4. An address check of the Sex Offender Registry; and
- (c) Not be left alone in the presence of a child until copies of the background checks in accordance with paragraph (b) of this subsection have been received by the licensee.

Findings:

General: Based on Review of Documentation, observation and interview, the child care center failed to maintain employee records in accordance with regulatory requirements. Review of a staff file for an employee with the hire date of 9/4/15 failed to reveal a criminal records check. Observation of the Monkey Jungle room at 8:16 a.m. revealed that the individual with the hire date of 9/4/15 was working alone with five (5) children for an undetermined amount of time. Interview with the director revealed that the individual had a completed criminal records check; however the director was unable to locate the documentation at the time of the inspection.

305 - Background checks/discharged

- (c) An individual who is confirmed by an address check of the Sex Offender Registry and supporting documentation as a registered sex offender;
- (d) An individual who has been convicted of, or entered an Alford plea or plea of guilty to, a drug-related felony, and five (5) years has not elapsed since the person was fully discharged from imprisonment, probation, or parole;
- (e) A director who has been convicted of, or entered an Alford plea or a plea of guilty to, a felony offense involving fraud, embezzlement, theft, or forgery; and
- (f) An individual who has been convicted of, or has entered an Alford plea or a plea of guilty to, an offense under a criminal statute of the United States or of another state similar to an offense specified in this subsection.
- (7) An individual who has been convicted of, or entered an Alford plea or a plea of guilty to, a nonviolent felony or misdemeanor not specified in this section shall be handled on a case-by-case basis by the licensee with consideration given to the:
- (a) Nature of the offense;
- (b) Length of time that has elapsed since the event; and
- (c) Individual's life experiences after conviction, Alford plea, or guilty plea.

310 - Personnel File

 - c. Criminal records check from any previous state of residence completed once if:
 - (i) The individual resided outside the state of Kentucky in the last five (5) years; and
 - (ii) No criminal records check has been completed for the individual's previous state of residence; and
 - d. An address check of the Sex Offender Registry;

315 - Educational Requirements

922 KAR 2:110. Section 5. Staff Requirements.

- (1) Child-care center staff:
- (a) Hired after January 1, 2009, who have supervisory power over a minor and are not enrolled in secondary education, shall have a:
1. High school diploma;
 2. GED or qualifying documentation from a comparable educational entity; or
 3. Commonwealth Child Care Credential as described in 922 KAR 2:250;

Findings:

General: Based on Review of Documentation, and interview, the child care center failed to maintain employee records in accordance with regulatory requirements. Review of staff files failed to reveal documentation for an employee with the hire date of 9/8/14 to verify that the individual had completed a high school diploma, a GED or a Commonwealth Child Care Credential. Interview with the director revealed that the individual had completed a GED; however the documentation was not available for review at the time of the inspection.

320 - TB Verification

Not In Compliance

922 KAR 2:110. Section 5. Staff Requirements.

- (1) Child-care center staff:
- (b) Shall provide, prior to employment and every two (2) years thereafter:
1. A statement from a health professional that the individual is free of active tuberculosis; or
 2. A copy of negative tuberculin results.

Findings:

General: Based on Review of Documentation, the child care center failed to maintain employee records in accordance with regulatory requirements. Review of records failed to reveal current documentation from a health care professional to verify that an employee with the hire date of 1/6/15 was free from active TB at the time of the inspection.

325 - CPR/First Aid Coverage

In Compliance

922 KAR 2:110. Section 5. Staff Requirements.

- (3) For a child-care center licensed for infant, toddler, or preschool-age children, at least one (1) person on duty and present with the children shall be currently certified by a cabinet-approved training agency in the following skills:
- (a) Infant and child cardiopulmonary resuscitation; and
- (b) Infant and child first aid.

Findings:

General: Based on Observation, and interview, the child care center failed to maintain food service in accordance with regulatory requirements. Observation of the lunch meal revealed spaghetti and meat sauce, green beans and oranges with milk. Interview with director revealed that the bread had expired and was not able to be served that day and the packaging for the pasta did not have information to verify that the pasta was whole grain or enriched. Based on observation and interview, the surveyor was unable to verify that a whole grain component was served for the lunch meal. Continued observation of lunch service revealed that the spaghetti served to the children in the Monkey Jungle room failed to have a sufficient amount of meat in the meat sauce to be considered a serving of protein. Interview with the director revealed that the meat had apparently not been stirred into the sauce enough as the remainder of the classes had more than a sufficient amount of meat in their sauce. Observation confirmed that the only class failing to receive a sufficient serving of protein was the Monkey Jungle room.

Review of records and observation revealed that eight (8) children failed to have their attendance and time of arrival documented in accordance with regulatory requirements at the time of the inspection.

Interview with the director revealed that a copy of the plan of correction was not made prior to submitting to the Cabinet for approval. Continued interview with the director revealed that the documentation related to the civil penalty notice was not maintained after the payment was made as there was not an awareness of that requirement.
