General: Based on Review of Documentation, staff person hired 1/2011 did not have a completed child abuse and neglect central registry check or criminal records check on file which had been conducted within 90 days of employment. The Director presented a criminal records check from 10/2007 and CAN check from 10/2009 but acknowledged that these were conducted prior to the staff person's hire date and that this did not meet minimum licensing requirements.




