(9) Floors, walls, and ceilings shall be smooth, in good repair, and constructed to be easily cleaned.

Findings:

General: Based on observation, the child care center failed to comply with regulations regarding premises. In the following rooms there were several areas of paint chipping: preschool, one-year-old room, school age room, six and seven-year-old room, and the men's hallway bathroom.

In the school age room, the floor board by the cubby was separating causing a trip hazard. In the same aforementioned room there was a broken floor tile in the art center.

590 - Toilet

922 KAR 2:120. Section 10. Toilet, Diapering, and Toiletry Requirements. (4) Each toilet shall:

(a) Be kept in clean condition;

- (b) Be kept in good repair;
- (c) Be in a lighted room; and


General: Based on observation and interview, the child care center failed to comply with regulations regarding premises. Observation in the two-year-old bathroom revealed the toilet tank top was missing and not covered, exposing the inside piping. Interview with the staff in charge with the hire date of 04/06/2006 revealed he was unaware the tank top for the toilet was missing.

In the following two (2) bathrooms there was no ventilation to outside air: men's hallway bathroom and women's bathroom.
