(I) Assure the health, safety, and comfort of each child;

Findings:

General: Based on observation, the child care center director failed to assure compliance with regulatory requirements in regards to the health, safety and comfort of children in care. There was a plunger located next to the toilet inside the bathroom in the Three's Room at the time of the survey. There was a toilet bowl brush located next to the toilet inside the bathroom in the Two's Room at the time of the survey.

410 - Training Not In Compliance

922 KAR 2:090. Section 11. Staff Requirements.

- (16) In accordance with KRS 199.896(15) and (16), a staff person with supervisory authority over a child shall complete the following:
- (a) Six (6) hours of cabinet-approved orientation within the first three (3) months of employment;
- (b) Nine (9) hours of cabinet-approved early care and education training within the first year of employment, including one and one-half (1 1/2) hours of cabinet-approved pediatric abusive head trauma training; and
- (c) Fifteen (15) hours of cabinet-approved early care and education training during each subsequent year of employment, including one and onehalf (1 ½) hours of cabinet-approved pediatric abusive head trauma training completed once every five (5) years.

Findings:

General: Based on observation, review of documentation and interview, the child care center failed to maintain employee records in accordance with regulatory requirements. Review of the presented employee records revealed two (2) staff members with hire dates 11/16/17 and 4/6/06 whose file did not contain documentation to verify recent completion of the one and one-half (1 ½) hours of pediatric abusive head trauma. Review of the presented employee records revealed two (2) staff members with hire dates 9/9/19 and 6/12/19 whose file did not contain documentation to verify completion of the six (6) hours of orientation. Review of the presented employee records revealed a staff member with hire date 5/28/13 whose file did not contain documentation to verify completion of the fifteen (15) hours of cabinet approved training. Review of ECE-TRIS verified that the staff member did not complete the fifteen hours of cabinet approved training. Upon request, the staff member in charge did not present training documentation for the aforementioned staff members at the time of the survey.

Findings:

General: Based on observation, the child care center failed to maintain the premises in accordance with regulatory requirements. There were two water stains located in the ceiling above the cubbies in the Two's Room at the time of the survey. There were several water stains in a ceiling tile located above the sink in the One's Room at the time of the survey. There was water inside the fluorescent light covers located above the play area and above the cribs in the Infant Room at the time of the survey.

580 - Floors, Walls, Ceilings

(9) Floors, walls, and ceilings shall be smooth, in good repair, and constructed to be easily cleaned.

Findings:

General: Based on observation, the child care center failed to maintain the premises in accordance with regulatory requirements. The black baseboard was not attached to wall under the sink inside the Men's Bathroom located outside the One's Room. The black baseboard was not attached to the wall at the entrance to the Women's Bathroom located outside the One's Room.

645 - Sink Not In Compliance

922 KAR 2:120. Section 10. Toilet, Diapering, and Toiletry Requirements.

- (3) A sink shall be:
- (a) Located in or immediately adjacent to toilet rooms;
- (b) Equipped with hot and cold running water that allows for hand washing;
- (c) Equipped with hot water at a minimum temperature of ninety (90) degrees Fahrenheit and a maximum of 120 degrees Fahrenheit;
- (d) Equipped with liquid soap;
- (e) Equipped with hand-drying blower or single use disposable hand drying material;
- (f) Equipped with an easily cleanable waste receptacle; and
- (g) Immediately adjacent to a changing area used for infants and toddlers.

Findings:

General: Based on observation, the child care center failed to maintain the premises in accordance with regulatory requirements. The sink located in the School-Age Room was not equipped with liquid soap at the time of the survey.

Hygienic Practices

685 - Diaper Changing Area/Surface 922 KAR 2:120. Section 10. Toilet, Diapering, and Toiletry Requirements.

- (10) When a child is diapered, the child shall:
- (b) Be placed on a surface that is:

Findings:

General: Based on observation, the child care center failed to comply with hygienic practices in accordance with regulatory requirements. The red and blue changing pad located in the One's Room was torn, exposing the absorbent material at the time of the survey. The changing table attached to the wall located in the Infant Room was not equipped with a changing pad at the time of the survey.

Findings:

General: Based on observation, the child care center failed to maintain an outdoor play area in accordance with regulatory requirements. There was trash on the bench located in the outdoor play area at the time of the survey.

755 - Protective Surface Not In Compliance

922 KAR 2:120. Section 4. Premises Requirements.

- (21) A protective surface shall:
- (a) Be provided for outdoor play equipment used to:
- 1. Climb;
- 2. Swing: and
- 3. Slide; and
- (b) Have a fall zone equal to the height of the equipment.

Findings:

General: Based on observation, the child care center failed to maintain an outdoor play area in accordance with regulatory requirements. There was no protective surface located at the bottom of two (2) of the red slides located in the Outdoor Play Area at the time of the survey.

760 - Fences Not In Compliance

922 KAR 2:120. Section 4. Premises Requirements.

- (23) Fences shall be:
- (a) Constructed of safe material;
- (b) Stable; and
- (c) In good condition.

Findings:

General: Based on observation, the child care center failed to maintain an outdoor play area in accordance with regulatory requirements. The metal pole was not attached to the metal fence in the back of the Outdoor Play Area at the time of the survey.

Equipment Not In Compliance

770 - Play Equipment Not In Compliance

922 KAR 2:120. Section 4. Premises Requirements.

- (24) Supports for climbing apparatus and large equipment shall be securely fastened to the ground.
- (25) Crawl spaces, such as tunnels, shall be short and wide enough to permit access by adults.
- (26) A sandbox shall be:
- (a) Constructed to allow for drainage;
- (b) Covered when not in use;
- (c) Kept clean; and
- (d) Checked for vermin prior to use.

Findings:

General: Based on observation, the child care center failed to maintain equipment in accordance with regulatory requirements. The gray climber located in the Outdoor Play Area was not securely anchored to the ground at the time of the survey. The red and blue monkey bars located in the Outdoor Play Area were not securely anchored to the ground at the time of the survey.

815 - Toys/Furniture Not In Compliance

922 KAR 2:120. Section 11. Toys and Furnishings.

- (1) All toys and furniture contacted by a child shall be:
- (a) Kept clean and in good repair; and
- (b) Free of peeling, flaking, or chalking paint.

Findings:

General: Based on observation, the child care center failed to maintain equipment in accordance with regulatory requirements. The blue alphabet rug located in the School-Age Room was dirty and stained at the time of the survey. Several of the red vinyl mats located in the School Age Room were torn, exposing the absorbent material at the time of the survey. The yellow vinyl climber located in the Three's Room was torn, exposing the absorbent material at the time of the survey. Several of the red, yellow and green mats located in the Two's Room were torn, exposing the absorbent material. Several of the blue, red and yellow mats located in the Preschool Room were torn, exposing the absorbent material.

- (2) Indoor and outdoor equipment shall:
- (a) Be clean, safe, and in good repair;
- (b) Meet the physical, developmental needs, and interests of children of different age groups;
- (c) Be free from sharp points or corners, splinters, protruding nails or bolts, loose or rusty parts, hazardous small parts, lead-based paint, poisonous material, and flaking or chalking paint; and
- (d) Be designed to guard against entrapment or situations that may cause strangulation.

Findings

General: Based on observation, the child care center failed to maintain equipment in accordance with regulatory requirements. Two (2) of the ride on trikes located in the outside play area were missing one (1) of the handle bar cushions at the time of the survey. One (1) of the bikes attached to the riding apparatus located in the Outside Play Area was missing the pedal, causing the apparatus not to work properly. Three (3) of the black tires attached to the pink and yellow ride in toy car located in the Outdoor Play Area were cracked open at the time of the survey. The black and beige basketball located in the Outdoor Play Area was deflated and dry-rotted at the time of the survey. The white and blue basketball located in the Outdoor Play Area was deflated and dry-rotted at the time of the survey.

825 - Toys Not In Compliance

922 KAR 2:120. Section 11. Toys and Furnishings.

- (3) Toys shall be:
- (a) Used according to the manufacturer's safety specifications;
- (b) Durable: and
- (c) Without sharp points or edges.

Findings:

General: Based on observation, the child care center failed to maintain equipment in accordance with regulatory requirements. The knob was broken off the cabinet door of the white and yellow toy sink located in the School Age Room at the time of the survey. The white plastic tub located in the white and yellow toy sink in the School-Age Room was cracked, exposing sharp plastic pieces at the time of the survey. One-half (1/2) of one of the white knobs was broken off the white and purple toy kitchen located in the School-Age Room at the time of the survey. The faucet was missing from the white and purple toy kitchen located in the School-Age Room at the time of the survey.

Findings

General: Based on observation, the child care center failed to maintain food service in accordance with regulatory requirements. There was two (2) Dr. Brown bottles located inside the black mini-fridge in the Infant Room that were not labeled at the time of the survey.

1130 - Menu Not In Compliance

922 KAR 2:120. Section 9. Food and Meal Requirements.

- (16) A weekly menu shall be:
- (a) Prepared;
- (b) Dated;
- (c) Posted in advance in a conspicuous place;
- (d) Kept on file for thirty (30) days; and
- (e) Amended in writing with any substitutions on the day the meal is served.

Findings:

General: Based on observation, the child care center failed to maintain food service in accordance with regulatory requirements. The menu was not posted at the time of the survey.

General: Based on review of documentation and interview, the child care center failed to maintain children's records in accordance with regulatory requirements. Review of the presented children's records revealed a child with enrollment date 10/7/19 whose file did not contain the name of the child' physician. Upon request, the staff member in charge did not present the documentation for the aforementioned child at the time of the survey.

Review of the presented employee records revealed four (4) staff members with hire dates 11/16/17, 4/13/17, 5/28/13 and 3/13/17 whose file did not contain a dated current annual professional development plan. Upon request, the staff member in charge did not present the documentation for the aforementioned staff members at the time of the survey.
