General: Based on observation at approximately 3:45 pm revealed a child walking from the Girls' Restroom unsupervised. Further observation at approximately 4:30 pm revealed one (1) child was allowed to walk to restroom unsupervised. The staff in charge stated during interview she thought it was acceptable for a child to walk to the restroom alone as long as the staff member was able to watch them walk to the restroom. The staff in charge further stated that the issue would be addressed promptly.
