General: Based on review of documentation, it was found that one staff member has lived in Mississippi within the last five years. This staff member did not have the out of state background check, sex offender registry check, or child abuse check in the staff file. The date of hire for this staff member is 10/08/2018. It is important to note that this staff member was not working alone during the inspection.

922 KAR 2:090. Section 10. Director Requirements and Responsibilities.

(1) A director shall:

(I) Assure the health, safety, and comfort of each child;

Findings:

General: Based on observation, this regulatory requirement was not met. The following was found:

1. During a tour of the facility, the surveyor observed that the roll of toilet paper that the children use in the bathroom area is stored in an unsanitary manner in four different classrooms (Room #201, Room #204, Room #203, and #205)

Toilet paper in these bathrooms were positioned on top of the toilet tank and on top of empty dispensers.

2. The surveyor observed toilet cleaning brushes being stored beside toilets in three different bathrooms (Room #204, Room #203, and Room #208). This manner of storage is not sanitary and promotes the spread of germs.

3. The surveyor observed white lights hung from the ceiling around the room in Room #205. Electrical cords were observed hanging loose down one of the walls and plugged into an electrical outlet near the floor. The cords were not secure and were accessible to the children.

4. During a tour of the facility, the staff person in charge stated that the indoor gross motor room is not currently being used due to Covid-19 concerns. When the surveyor toured the outdoor playground, it was noted that the toddler playground is no longer used by the children and is not currently being maintained. It is important to note that the staff person in charge made note of this on the diagram during the 4/3/19 renewal inspection. This was acceptable at the time due to the facility having an indoor gross motor room for the toddler to use.

The staff person in charge stated during interview that the toddler children currently play on the same playground as the older children; however, a tour of this playground during the inspection found that the majority of the equipment is not safe for the toddler age group to play on. This playground contains a few age appropriate play structures for toddlers; however, most of the climbing and sliding structures are over three feet tall and there is no barrier to prevent the toddler from having access to them, which poses a safety issue.

922 KAR 2:090. Section 11. Staff Requirements.

(16) In accordance with KRS 199.896(15) and (16), a staff person with supervisory authority over a child shall complete the following:

(a) Six (6) hours of cabinet-approved orientation within the first three (3) months of employment;

(b) Nine (9) hours of cabinet-approved early care and education training within the first year of employment, including one and one-half (1 1/2) hours of cabinet-approved pediatric abusive head trauma training; and

(c) Fifteen (15) hours of cabinet-approved early care and education training during each subsequent year of employment, including one and onehalf (1 ½) hours of cabinet-approved pediatric abusive head trauma training completed once every five (5) years.

Findings:

General: Based on review of documentation, the following was found:

1. It was found that three staff members did not have Pediatric Abusive Head Trauma training that had been completed within the last five years. The dates of hire for these staff are: 08/01/2013, 06/28/2013, and 04/25/2014. In addition, there were two staff members who do not have Pediatric Abusive Head Trauma training. These staff members have been employed at the facility for over one year. The date of hire is 03/05/2019 and 03/25/2019.

2. It was found that five staff members did not have the required orientation training. These staff members have been employed at the facility for longer than ninety days. The dates of hire are: 12/20/2019, 11/14/2018, 10/10/2016, 01/04/2013, and 12/09/2019. A review of ECE-TRIS confirmed these findings.

Findings:

General: Based on observation, this regulatory requirement was not met. The following was found:

1. The surveyor observed a clear gel air freshener and a container of Purell hand sanitizing wipes positioned on top of a three-drawer storage unit in the children's bathroom in Room #201. These items were accessible to the children. The label on the back of both containers read "Keep Out of Reach of Children".

2. The surveyor observed a spray bottle labeled Neutral Disinfectant, a spray bottle labeled bleach water and a can of disinfectant spray being stored in a tall white storage cabinet in Room #304. The cabinet did not contain a lock; therefore, these items were accessible to the children. The surveyor also observed four cans of Febreeze deodorizing spray and a staff purse being stored in a low blue shelving unit in this same classroom. The shelves were open (no doors); therefore, these items were also accessible to the children. A handwritten note on the front of the shelf stated, "Do not get in this shelf with out asking".

Findings:

General: Based on observation, this regulatory requirement was not met. The following was found:

1. The sink cabinet in the children's bathroom in Room #203 was in dis-repair. A section of the trim around the bottom was split open and contained jagged edges.

2. The wooden trim on the bathroom door in Room #207 was in dis-repair. A section of the wood was broken and had been removed which exposed jagged/splintered edges.

Outdoor Play Area

750 - Playground Conditions

922 KAR 2:120. Section 4. Premises Requirements.

(20) An outdoor play area shall be:

(d) Safe from foreseeable hazard;

(e) Well drained;

(f) Well maintained;

(g) In good repair; and

(h) Visible to staff at all times.

Findings:

General: Based on observation, this regulatory requirement was not met. During a tour of the outdoor playground, the surveyor observed the following:

1. Several inches of water was pooled at the base of a green slide. Children were observed playing on this piece of equipment at the time. The surveyor observed children climb to the top platform of the slide and then jump off from the top to avoid the water at the bottom.

2. Several large plastic storage containers (approximately 15) were observed in a pile on the playground in front of the storage building.

3. A large blue and red sensory table was positioned on the playground beside the storage building. The table did not contain a lid. Several inches of water had pooled inside different sections of the table along with sticks and mulch.

4. The cover was missing on a round sidewalk drain in front of the exterior door that staff and children use to get to the playground which exposed an open hole approximately four - five inches wide.

755 - Protective Surface

922 KAR 2:120. Section 4. Premises Requirements. (21) A protective surface shall: (a) Be provided for outdoor play equipment used to: 1. Climb;

2. Swing; and

3. Slide; and

(b) Have a fall zone equal to the height of the equipment.

Findings:

General: Based on observation, this regulatory requirement was not met. During a tour of the outdoor play area, the following was found:

1. The surveyor observed bare dirt and sparse mulch at the base of a green slide connected to a wooden ship structure.

- 2. A lime green and grey climber with a slide was positioned on grass and dirt.
- 3. Bare dirt and sparse mulch was observed at the base of a red slide.
- 4. Sparse mulch was observed under a set of monkey bars that were approximately seven feet tall.
- 5. The base of a slide on a Little Tikes climber/slide structure was positioned approximately six inches from a chain link fence.

Not In Compliance (1) All toys and furniture contacted by a child shall be: (a) Kept clean and in good repair; and (b) Free of peeling, flaking, or chalking paint. Findings: General: Based on observation, this regulatory requirement was not met. During a tour of Room #304, the surveyor observed an adult size couch that was in disrepair. The fabric on the arm of the couch was ripped all the way down and hanging loose.

820 - Indoor/Outdoor Equipment

922 KAR 2:120. Section 11. Toys and Furnishings.

(2) Indoor and outdoor equipment shall:

(a) Be clean, safe, and in good repair;

(b) Meet the physical, developmental needs, and interests of children of different age groups;

(c) Be free from sharp points or corners, splinters, protruding nails or bolts, loose or rusty parts, hazardous small parts, lead-based paint,

poisonous material, and flaking or chalking paint; and

(d) Be designed to guard against entrapment or situations that may cause strangulation.

Findings:

General: Based on observation and interview, this regulatory requirement was not met. The following was found:

1. During a tour of Room #205, the surveyor observed a cabinet door from the dramatic play kitchen set lying on top of one of the pieces. The staff person working in the classroom stated that the cabinet door had recently broken off at the hinge.

2. During a tour of the outdoor playground, the surveyor observed three broken seats on a tricycle merry-go-round and two broken seats on a bouncy see-saw structure. Also, both end caps on a balance beam were missing which exposed a rusty metal edge.
