Review of a CAN check and subsequent interview with a staff member with a hire date of 06/03/2015 revealed that she formerly lived in Florida until May, 2013. Document review revealed a Kentucky CAN background check had been run upon hiring, but no out-of state background check was run. The deficiency was explained to and acknowledged by the staff in charge at exit interview."

Record review at survey revealed that the following staff members identified by each hire date had less than fifteen (15) hours of cabinet-approved early care and education training - 02/23/2007, 08/24/2007, 12/4/2012, and 10/12/09. During exit interview, the Staff in Charge acknowledged the accuracy of these reported deficiencies to the surveyor.

General: Based on observation the child care center failed to comply with regulatory requirements. Observation at survey revealed: 1) a sharp rusted nail protruding upwards about one and a half (1 1/2) inches from a rotting railroad tie-like post lying on the ground and oriented in an east-west direction in the older outdoor children's larger playground; 2) the same playground also contains a rotting railroad tie-like post on the north side and 3) a slanted wooden climbing board in the same play area has several rotted boards which, observation revealed, are not capable of supporting any weight at all. Additionally, observation of the smaller children's playground in the north side of the outdoor play area revealed a rusty metal see-saw with a loose bolt positioned precariously along a railroad tie-like post.
