### Findings:

General: Based on observation, the surveyor found the following:

- 1. There was a loose electrical outlet cover located by a bookshelf; the gap was big enough for a child to stick something in the plug. Therefore, the child care center failed to comply with the health, safety, and comfort of the children.
- Staff reported that she would put in a work order for the plug to be repaired.
- 2. There was a foul sewer smell when in the restroom located in the classroom. During interview, staff reported that the smell goes away when the toilet is flushed; however, the smell comes back.

Staff stated that she would put in a work order to attempt to have the smell eliminated.

General: Based on observation, there was one (1) toy that had an approximate one (1) inch screw that was protruding out from the toy. The toy appeared to be a handle of a riding toy and was accessible to the children. The handle of the riding toy was located in the fenced area connecting the building and the playground. During interview, staff reported that she would clean the connecting area from the building to the playground.

General: Based on review of documentation, the surveyor found that a staff member's (DOH: 7/29/16) file contained a Professional Development (PD) Plan that was dated for 7/29/19.

During interview, staff stated that she did not know where the staff member's current PD Plan was located and the surveyor was not presented with a more up-to-date PD Plan; therefore, the surveyor could not determine if the staff member's PD Plan was completed annually.

General: Based review of documentation, the surveyor found a posted statement of deficiency/plan of correction dated for 09/06/18.

The child care center had additional inspections conducted on the following dates, which occurred after the 09/06/18 date: a no deficiency inspection conducted on 08/06/19 and a statement of a deficiency inspection conducted on 12/07/20; however, the center did not have a no deficiency letter posted or a statement of deficiency/plan of correction posted for those inspections.

During interview, staff stated that she would find and post the statement of deficiency.
