#### 922 KAR 2:090. Section 10. Director Requirements and Responsibilities.

(1) A director shall:

1260 - Emergency Regulation

(n) Assure that a person acting as a caregiver of a child in care shall not be left alone with a child, if the licensee has not received the results of the background checks as described in 922 KAR 2:280;

#### Findings:

General: Based on observation, interview and review of documentation, a caregiver did not have processed and approved name-based background checks on file and was left alone and supervised seven (7) children for approximately fifteen (15) minutes in the toddler room on 01/07/2021. Interviews revealed the caregiver was left alone when another caregiver left for a break.

## 922 KAR 2:410E. Emergency Regulation.

Due to the current declared public health emergency caused by the Novel Coronavirus Disease (COVID-19), licensed child care centers must operate under Centers for Disease Control and Prevention and public health guidelines, as mandated by 922 KAR 2:410E, to prevent the spread of COVID-19.

### Findings:

General: Based on observation, interview and review of documentation, a new staff shall undergo name-based background in accordance with 922 KAR 2:280 and shall not be left alone with children until name-based background checks have been approved and returned, in accordance with 922 KAR 2:410E Section 11(3). A caregiver hired 01/04/2021, did not have processed and approved name-based background checks on file and was left alone and supervised seven (7) children for approximately fifteen (15) minutes in the toddler room on 01/07/2021.
