Findings:

General: Based on interview and review of documentation, it was found that staff person hired 9/16/19 did not have evidence of a high school diploma, GED or Commonwealth Child Care Credential on file in the facility. In an interview with the staff person in charge it was determined that the staff person still attends high school; however, there was no supporting documentation on file from the school.

410 - Training Not In Compliance

- (16) In accordance with KRS 199.896(15) and (16), a staff person with supervisory authority over a child shall complete the following:
- (a) Six (6) hours of cabinet-approved orientation within the first three (3) months of employment;
- (b) Nine (9) hours of cabinet-approved early care and education training within the first year of employment, including one and one-half (1 $\frac{1}{2}$) hours of cabinet-approved pediatric abusive head trauma training; and

General: Based on review of documentation, the following was found:

1. Staff person hired 1/15/19 did not have evidence of completing the required orientation training in the first three (3) months of employment. The certificate on file was dated 7/31/19.

- 3. Staff person hired 8/22/18 did not have evidence of completing fifteen (15) hours of annual early care and education training on file in the facility.
