## Findings:

General: Based on review of documentation, the following was found:

- 1.) Four staff members did not have evidence of a negative TB skin test on file at the facility. The dates of hire for these staff members are: 11/11/2016, 02/18/2017, 02/04/2020, and 02/20/2020.
- 2.)There were three staff members at the facility that did not have evidence of a negative TB screening that had been obtained within the last two years. The dates of hire for these staff are: 03/31/2016, 08/23/2016, and 09/26/2018.

General: Based on review of documentation, it was found that two staff members did not meet the 15-hour training requirement. The dates of hire for these staff are 12/16/2014 and 02/18/2017. A review of ECE-TRIS confirmed these findings.

General: Based on observation, the following was found:

- 1.) There were numerous plastic bags in an unlocked cabinet underneath the sink. This was found in all three classrooms of the facility.
- 2.) In the stem room, there were two containers of fish food in the top drawer by the sink in the classroom. The labels on the container read keep out of reach of children.
- 3.) In the stem room, there was a stapler in an unlocked cabinet. This stapler was on the third shelf, therefore it was accessible to the children in care.
  4.) In the preschool room, there was a tube of Gold Bond lotion and a sharpie marker in the top drawer next to the sink.
- 5.) In the preschool room, there was a roll of trash bags in one of the drawers next to the sink.
