Findings:

General: Based on interview and observation, a caregiver lifted a two-year-old child by his left arm and pulled him before she lifted him off the ground by both arms in the two-year-olds' room on 9/2/21. The caregiver walked approximately six (6) steps towards a table and placed the child in a chair. The caregiver immediately pushed the chair to the table and placed her right foot on the floor between the back legs of the chair. As the child tried to push himself away from the table, he could not move due to the placement of the caregiver's foot on the floor behind the chair.

A caregiver did not follow the policy regarding lifting children when she lifted a two-year-old child by his left arm and pulled him before she lifted him off the floor under both arms on 9/2/21.
