225 - Licensee Responsibility Not In Compliance

**922 KAR 2:090. Section 8. General.**  
**(1) A licensee shall:**  
**(a) Be responsible for the operation of the child-care center pursuant to this administrative regulation, 922 KAR 2:120, and 922 KAR 2:280; and**  
**(b) Protect and assure the health, safety, and comfort of each child.**

**Findings:**

General: Based on interview and observation, a caregiver lifted a two-year-old child by his left arm and pulled him before she lifted him off the ground by both arms in the two-year-olds' room on 9/2/21. The caregiver walked approximately six (6) steps towards a table and placed the child in a chair. The caregiver immediately pushed the chair to the table and placed her right foot on the floor between the back legs of the chair. As the child tried to push himself away from the table, he could not move due to the placement of the caregiver's foot on the floor behind the chair.

**Director Requirements** Not In Compliance

350 - Staff Management/Policy Development/Supervision Not In Compliance

**922 KAR 2:090. Section 10. Director Requirements and Responsibilities.**  
**(1) A director shall:**  
**(e) Manage the staff in their individual job descriptions;**  
**(f) Assure the development, implementation, and monitoring of child-care center plans, policies, and procedures;**  
**(g) Supervise staff conduct to ensure implementation of program policies and procedures;**

**Findings:**

General: Based on interview, review of documentation and observation, the center's policy regarding lifting children stated children should be lifted under both arms. A caregiver did not follow the policy regarding lifting children when she lifted a two-year-old child by his left arm and pulled him before she lifted him off the floor under both arms on 9/2/21.
