For a school-age child, within scope of vision or range of voice; Findings: General: Based on Review of Documentation, interview and observation, the child care center failed to maintain adequate supervision with qualified staff in accordance with regulatory requirements. Review of staff files revealed that two (2) staff with the hire date of 8/12/13 did not have the required official completed background checks as described in Section 3(1)(e)6 of this administrative regulation. Interview with the director revealed that the NEXIS reports were national background checks that the human resources office of the archdiocese used for employment and that she was not aware that those reports did not qualify under regulatory reguirements. Observation revealed that each of the two unqualified staff members were working alone in room #3 for four-year-old children and room #7 for three-year-old children at the time of the survey. 15 - Activity Areas/Equipment/Materials In Compliance

Findings:

General: Based on Observation, review of records and interview, the child care center director failed to assure compliance with regulatory requirements. Observation revealed that staff with the hire date of 8/12/13 was working alone with six (6) three-year-old children and another staff with the same hire date was working alone with thirteen (13) four-year-old children at the time of the survey. Review of staff files revealed that the above mentioned staff did not have the required background check completed and available for review at the time of the survey, but had completed NEXIS reports available. Interview with the director revealed that the NEXIS reports were national background checks that the human resources office of the archdiocese used for employment and that she was not aware that those reports did not qualify under regulatory requirements.

Findings:

General: Based on Review of Documentation, interview and observation, the child care center failed to maintain employee records in accordance with regulatory requirements. Review of the staff files revealed that two (2) staff with the same hire date of 8/12/13 and staff with hire date of 1/3/13 did not have the required background check on file or available for review at the time of the survey. Interview with the director revealed that the NEXIS background check was a national background check and was the one used by the archdiocese, not realizing that it did not meet the regulation requirements. Observation revealed that two (2) staff members with the same hire date of 8/12/13 were working alone with children at the time of the survey.
