**(19) The Department of Housing, Buildings and Construction, State Fire Marshal's Office, and cabinet shall be contacted concerning a planned new building, addition, or major renovation prior to construction.**

**Findings:**

General: Based on Review of Documentation, on 08/07/15 DRCC surveyor received an email from the State Fire Marshal's office stating that St. Dominic Elementary had requested an inspection from their office regarding renovation that had recently been completed. She stated that it was required for her licensure to have the inspection. The State Fire Marshal completed their inspection on 08/03/15. The cabinet was not notified before the renovation started. A visit was not completed until 08/26/15.
