#### Findings:

General: Based on Review of Documentation, it was found that on 9-9-13 a four (4) year old child was left unattended in a bathroom in the gym while the rest of the class was taken back to the classroom. An office employee heard the child crying and went to comfort her. When the child's classroom teacher was called regarding the child's whereabouts, it was found that the teacher had not yet discovered that the child was missing. The child was completely unsupervised for less than one (1) minute, however, the office employee is part of the school system, not the licensed childcare.
