Based on attendance records, the last child arrived in the classroom at 10:42 a.m. The classroom remained over the maximum group size until 11:00 a.m. In addition, it was found that there were twenty-one (21) children in the Two Year Old classroom, which exceeds the maximum group size by one (1) child. Based on attendance records, the last child arrived in the classroom at 10:43 a.m. The classroom remained over the maximum group size until 11:05 a.m.</p>
