General: Based on observation, it was found that the Fire Marshal report at the facility had not been obtained within the last two years. The staff members in charge reported that the Fire Marshal had been out to the facility recently, but they could not find the report.

Findings:

General: Based on observation during a tour of the toddler classroom, there was a child who was laying on the diaper changing pad because there was an unknown object in his nose. The teacher did not have gloves on while she was trying to retrieve the object.

Not In Compliance 360 - Caregiver Alone

922 KAR 2:090. Section 10. Director Requirements and Responsibilities.

- (n) Assure that a person acting as a caregiver of a child in care shall not be left alone with a child, if the licensee has not received the results of the background checks as described in 922 KAR 2:280;

Findings:

General: Based on observation and review of documentation, staff person hired 11/2/2020, did not have the results or evidence of application for a CA/N check on file in the facility. The staff person was alone supervising a group of eight children, ages three- and fours-years-old.

922 KAR 2:090. Section 11. Staff Requirements.

- (1) Child-care center staff:
- (a) Hired after January 1, 2009, who have supervisory power over a minor and are not enrolled in secondary education, shall have a:
- 1. High school diploma:
- 2. GED or qualifying documentation from a comparable educational entity; or
- 3. Commonwealth Child Care Credential as described in 922 KAR 2:250;

General: Based on review of documentation, staff person hired 9/3/19, did not have evidence of a high school diploma, GED or Commonwealth Child Care Credential on file in the facility.

410 - Training **Not In Compliance**

922 KAR 2:090. Section 11. Staff Requirements.

- (16) In accordance with KRS 199.896(15) and (16), a staff person with supervisory authority over a child shall complete the following:
- (a) Six (6) hours of cabinet-approved orientation within the first three (3) months of employment;
- (b) Nine (9) hours of cabinet-approved early care and education training within the first year of employment, including one and one-half (1 ½) hours of cabinet-approved pediatric abusive head trauma training; and
- (c) Fifteen (15) hours of cabinet-approved early care and education training during each subsequent year of employment, including one and onehalf (1 ½) hours of cabinet-approved pediatric abusive head trauma training completed once every five (5) years.

Findings:

General: Based on review of documentation, the following was found:

- 1. Staff person hired 6/15/2020, did not have evidence of completing the required orientation training in the first three months of employment.
- 2. Staff persons hired 7/17/18 and 9/26/18, did not have evidence of completing the Pediatric Abusive Head Trauma training within the first year of employment. A review of ECE-TRIS records supports the information found during the survey.

Findings:

General: Based on observation, the following was found:

- 1.) There was a staff member's purse as well as a Starbucks coffee drink sitting on top of a shelf in the classroom of the Pre-K 1 classroom. These items were accessible to the children in the classroom
- 2.) During a walkthrough of the kitchen, it was found that the door was propped open. In the kitchen, there was a large knife sitting out near the sink area.

580 - Floors, Walls, Ceilings **Not In Compliance**

922 KAR 2:120. Section 4. Premises Requirements.

(9) Floors, walls, and ceilings shall be smooth, in good repair, and constructed to be easily cleaned.

General: Based on observation, the following was found:

- 1.) In the two-year-old classroom, there were crayon marks on the walls.
- 2.) In the toddler classroom, there was an area of the wall that needed to be repainted. It could not be determined if there was a substance on the wall or if the paint was beginning to wear/rub off.

650 - Toilet Not In Compliance

922 KAR 2:120. Section 10. Toilet, Diapering, and Toiletry Requirements.

- (4) Each toilet shall:
- (a) Be kept in clean condition;
- (b) Be kept in good repair;
- (c) Be in a lighted room; and
- (d) Have ventilation to outside air.

Findings:

General: Based on observation, the following was found:

- 1.) There was urine and toilet paper in the toilet located in the restroom of the two-year-old classroom.
- 2.) There was urine in the toilet of the boys bathroom located in the school-age classroom

- (1) All toys and furniture contacted by a child shall be:
- (a) Kept clean and in good repair; and
- (b) Free of peeling, flaking, or chalking paint.

Findings:

General: Based on observation, the following was found:

- 1.) In the preschool classroom, there was a rug that was ripped on one of the corners.
- 2.) In the early preschool classroom, there was a cubed storage shelf where the art supplies were being stored. In one of the cubes, there was a large brown substance. In addition, there was a bench that had a purple paint stain.
- 3.) In the school-age classroom, there was a blue rug that was very dirty and stained.
- 4.) In the two-year-old classroom, there was a wooden climbing toy. This climbing toy was sitting on a white and blue mat. This mat was very dirty and dingy. In addition, this climber had carpet on it; however, there was an area of the carpet that was missing, which left the wood exposed. This wood was rough and could have splintered. In addition, there was an excessive amount of crayon marks on the walls, a doll house, and blocks in this classroom.

- 2.) Soft toys were available to the children in the preschool classroom.
