**Findings:**

General: Based on Observation, and interview, the child care center failed to maintain adequate supervision in accordance with regulatory requirements. Observation of the two (2) year old classroom on 03/21/16 at 9:18 AM revealed a child who left the classroom for toileting and was out of sight and sound of the teacher for less than one (1) minute, as the teacher was in the far left corner with her back to the location of exit. Further observation of the three (3) year old classroom revealed a child in the bathroom on 03/21/16 at 9:30 AM, out of sight of the classroom teacher for less than three (3) minutes. Additional observation of the two (2) year old classroom at 9:40 AM revealed a two (2) year old child left the classroom and stood in the hallway close to the bathroom, out of sight and sound of the teacher for less than a minute, as the teacher stood in the far left corner with her back to the location of exit. Interview with the child care center teacher in the two (2) year old classroom, revealed she sometimes used mirrors on the walls, located by the exit, to observe children when they left the classroom for toileting.

Findings:

General: Based on Observation, and interview, the child care center failed to comply with staffing regulatory requirements with regard to ratios and group size. Observation of the nursery at 9:10 AM on 03/21/16 revealed seven (7) children in the classroom and one (1) teacher, who was also the director. The classroom was observed to be over ratio based on both the minimum staff/child ratio and maximum group size, until 9:35 AM. Exit interview with the child care center director revealed acknowledgement of the deficiency.

Findings:

General: Based on Observation, and interview, the child care center failed to comply with staffing regulatory requirements with regard to ratios and group size. Observation of the nursery at 9:10 AM on 03/21/16 revealed seven (7) children in the classroom and one (1) teacher, who was also the director. Interview with the child care center director revealed the youngest child in the room was five (5) months old and the oldest was ten (10) years old. The classroom was observed to be over ratio based on the youngest child in the classroom and both the minimum staff/child ratio and maximum group size.

Findings:

General: Based on Observation, interview and record review, the child care center failed to comply with staffing requirements. Observation of the child care center Nursery revealed seven (7) children in the classroom in receipt of care. Interview with the child care center director revealed the oldest child in the classroom, who was ten (10) years of age, was her child. Record review revealed no documented evidence of enrollment documents for the school-aged child.

- (b) An address check of the Sex Offender Registry conducted on behalf of the applicant for a Type II child-care center and supporting documentation shall indicate that no individual residing in the household is a registered sex offender.

Findings:

General: Based on Observation, record review and interview, the child care center failed to comply with the regulatory requirements. Observation of the child care center on 03/21/16 revealed care was provided to two school-aged children. Review of the Division for Regulated Child Care (DRCC) records revealed the child care center was not licensed to provide care for school-aged children. Interview with the child care center director revealed she had not applied for consideration to provide school-aged child care. She also stated the children come to the child care center whenever school was not in session.

  - (f) An individual who has been convicted of, or has entered an Alford plea or a plea of guilty to, an offense under a criminal statute of the United States or of another state similar to an offense specified in this subsection.**

The child's immunization certificate expired on 03/20/16. Interview with the child care center director revealed she was not aware of the expired certificate for immunization.

**Findings:**

General: Based on Observation, record review and interview, the child care center failed to maintain children's records in accordance with regulatory requirements. Observation of the child care center revealed two (2) school-aged children who received care from 9:10 AM to 12:30 PM. Record review revealed no documented evidence of enrollment records for the children. Interview with the child care center director revealed the two (2) children observed, who were ten (10) years and eleven (11) years old, were her children and she did not have enrollment documents for them, as she did not consider them enrolled. She also stated the two (2) school-aged children attended the child care center whenever public school was not in session.

Further review of children's records for a child with an enrollment date of 11/16/15 revealed no documented evidence of a preferred physician as should have been indicated by the child's parent or legal guardian. Exit interview with the child care center director revealed acknowledgement of the deficiency.
