Findings:

General: Based on observation during the inspection walk through of the child-care center, the surveyor observed a blanket to be placed over three (3) children that were asleep in cribs in the One Year Old Classroom. The blanket was observed to be placed over each child and tucked into each side of the crib. Through interview with staff, the surveyor learned that the children had been asleep since approximately 11:10 a.m. and were approximately seven (7) months, nine (9) months, and eleven (11) months old. During interview, the Director stated that she was not aware the regulation had changed regarding the use of blankets for the children.
