- 2. GED or qualifying documentation from a comparable educational entity; or
- 3. Commonwealth Child Care Credential as described in 922 KAR 2:250;

Findings

General: Based on Review of Documentation, there were three (3) staff (hire dates: 4/11/18, 4/19/18 and 9/18/17) who did not have a copy of a high school diploma, GED or other qualifying documentation on file at the facility.

410 - Training Not In Compliance

922 KAR 2:090. Section 11. Staff Requirements.

- (16) In accordance with KRS 199.896(15) and (16), a staff person with supervisory authority over a child shall complete the following:
- (a) Six (6) hours of cabinet-approved orientation within the first three (3) months of employment;
- (b) Nine (9) hours of cabinet-approved early care and education training within the first year of employment, including one and one-half (1 $\frac{1}{2}$) hours of cabinet-approved pediatric abusive head trauma training; and
- (c) Fifteen (15) hours of cabinet-approved early care and education training during each subsequent year of employment, including one and one-half (1 ½) hours of cabinet-approved pediatric abusive head trauma training completed once every five (5) years.

Findings:

General: Based on Review of Documentation and ECE-TRIS records, it was found that a staff person hired 9/18/17 did not have evidence of having completed six (6) hours of orientation training.

Findings:

General: Based on Observation, in the two to three (2-3) year old room the children were observed playing with dried beans that had been placed in the sensory table. Due to the age of the children the dried beans are not developmentally appropriate and are a choking hazard.

- (b) Have a fall zone equal to the height of the equipment.

General: Based on Observation, a small, square Little Tikes climber was observed sitting on the grass against the fence beside a railroad tie. There was no protective surface. In addition there is not adequate space around the piece of equipment to ensure the proper fall zone

770 - Play Equipment **Not In Compliance**

922 KAR 2:120. Section 4. Premises Requirements.

- (24) Supports for climbing apparatus and large equipment shall be securely fastened to the ground.
- (25) Crawl spaces, such as tunnels, shall be short and wide enough to permit access by adults.
- (26) A sandbox shall be:
- (a) Constructed to allow for drainage;
- (b) Covered when not in use;
- (c) Kept clean: and
- (d) Checked for vermin prior to use.

Findings:

General: Based on Observation, the wooden cover on the outdoor sand table has a large gap between two (2) of the boards. This does not allow for the sand table to be completely covered when not in use.

820 - Indoor/Outdoor Equipment

922 KAR 2:120. Section 11. Toys and Furnishings.

- (2) Indoor and outdoor equipment shall:
- (a) Be clean, safe, and in good repair;
- (b) Meet the physical, developmental needs, and interests of children of different age groups;
- (c) Be free from sharp points or corners, splinters, protruding nails or bolts, loose or rusty parts, hazardous small parts, lead-based paint, poisonous material, and flaking or chalking paint; and
- (d) Be designed to guard against entrapment or situations that may cause strangulation.

Findings:

General: Based on Observation, the wooden cover on the sand table located on the playground had several nails protruding from the top. These nails are accessible to the children. There were areas where the wood was not smooth and was splintering that are accessible to the children. There was a large gap between two (2) of the boards that keeps the sand table from being completely covered.

Findings:

General: Based on Interview, it was found that the parents provide lunch for their child. However, the facility provides 2% milk if a child does not bring milk with their lunch. It was also found that the facility does no participate in the Federal Food Program. There is no documentation on file that verifies parents have given the facility permission to serve 2% milk instead of the required 1% for the age groups served.

Findings:

General: Based on Review of Documentation, found two (2) children enrolled since 8/17 who had immunization certificates on file that were no longer current.

- 1. Completed and signed by the child's parent;
- 2. Retained on file on the first day the child attends the child-care center; and

- b. Contact information to enable a person in charge to contact the child's:
- (i) Parent at the parent's home or place of employment;

Findings:

General: Based on Review of Documentation, there was one (1) child's enrollment information that had the name of a local clinic listed as the preferred hospital instead of a hospital.

Findings:

General: Based on Review of Documentation, there was no documented fire drill that included the date, time and names of children who participated for April, May and December of 2017 and February 2018.

1195 - Fire Drills Not In Compliance

- (12) A fire drill shall be conducted during hours of operation:
- (a) At least monthly; and
- (b) Documented.
- (13) An earthquake drill and a tornado drill shall be:
