Findings: <p>General: Interviews revealed that the staff member in charge was aware that hand, foot and mouth disease was rapidly spreading in the one-year-old room and did not require children with blisters to immediately be removed from other children in care inside the classroom even after it was determined that they had a fever. Interviews revealed that the center did not consider a child contagious with the virus until they had a fever. Interviews revealed that children were allowed to return to the center with scabs all over their body and without a physician's note. Review of the Centers for Disease Control and Prevention (CDC) website revealed that hand, foot and mouth disease can spread through nose and throat secretions (such as saliva, drool or nasal mucus, fluids from blisters or scabs and feces). Continued review of the CDC website revealed that people with hand, foot and mouth disease are usually most contagious during the first week that they are sick and can sometimes spread the virus to others for days or weeks after symptoms go away or if they have no symptoms at all. The licensee failed to maintain the health, safety and comfort of children in care when children showing signs of hand, foot and mouth disease were not removed from the other children in the one-year-old room.</p>
