<b>922 KAR 2:120. Section 2. Child Care Services.</b> <b>(3)(a) Each center shall maintain a child-care program that assures each child shall be:</b> <b>1. Provided with adequate supervision at all times by a qualified staff person who ensures the child is:</b> <b>a. Within scope of vision and range of voice; or</b> <b>b. For a school-age child, within scope of vision or range of voice;</b>	
<b>Findings:</b> General: Based on observation, this regulatory requirement was not met. Based on a review of video footage recorded on 3/21/2022, at approximately 11:49 AM, shows the staff person leave a group of six preschool children unsupervised. The staff member goes into the hall way and then comes back into the classroom.

<b>922 KAR 2:090. Section 8. General.</b> <b>(1) A licensee shall:</b> <b>(a) Be responsible for the operation of the child-care center pursuant to this administrative regulation, 922 KAR 2:120, and 922 KAR 2:280; and</b> <b>(b) Protect and assure the health, safety, and comfort of each child.</b>	
<b>Findings:</b> General: Based on observation, this regulatory requirement was not met. A review of video footage from 3/18/2022, shows a staff member grab a child by the arm and harshly pull her out of the home living area and then put her in a chair in another area of the room. A review of video footage from 3/21/2022, shows the same staff member pull the same child away from the sink by the arm in a rough manner and sits her on the floor. These instances of mishandling a child are unsafe and uncomfortable for the child.
