922 KAR 2:120. Section 2. Child Care Services.
(3)(a) Each center shall maintain a child-care program that assures each child will be:
1. Provided with adequate supervision at all times by a qualified staff person who:
a. Ensures the child is within scope of vision and range of voice; or
b. For a school-age child, within scope of vision or range of voice;

Findings:

General: Based on Observation and Interview, the child care center failed to maintain adequate supervision in accordance with regulations. Observation of the child care center on 10/14/15 revealed on five (5) separate occasions, 10:58am, 11:01am, 11:05am, 11:09am, and 11:18am, a two-year-old left the room being unattended by the owner/director and wandered into another area of the house, causing the two-year-old to be out of the scope of vision of the owner/director for at least one (1) minute each time. Observation of the child care center at 11:34am revealed seven (7) of the eight (8) children in care left the room unattended and wandered into another area of the house, while the owner/director cleaned up after lunch, causing the children to be out of the scope of vision of the owner/director for at least one (1) minute. During interview with owner/director, she acknowledged supervision was not maintained at various times throughout the duration of the survey.

Findings:

General: Based on Observation and Interview, the child care center failed to comply with staffing requirements. Observation of the child care center on 10/14/15 revealed the owner/director was the sole caregiver of nine (9) children ages one-year-old to three-years-old from 10:36am - 11:28am. During interview with owner/director, she acknowledged staff-to-child ratios were not maintained for the duration of the survey.

 - The adult resided outside the state of Kentucky in the last five (5) years; and

The check shall indicate that the adult has not been convicted of, or has not entered an Alford plea or a plea of guilty to, an offense under a criminal statute of the United States or of another state similar to an offense specified in subparagraph 1 of this paragraph; and
 - Copy of negative tuberculin results or a health professional's statement documenting that the adult is free of tuberculosis. Every two (2) years, the adult shall provide negative tuberculin results or health professional's statement documenting that the adult is free of tuberculosis.
- (b) An address check of the Sex Offender Registry conducted on behalf of the applicant for a Type II child-care center and supporting documentation shall indicate that no individual residing in the household is a registered sex offender.

155 - Staff Awake on Duty

General: Based on Review of Documentation, the child care center director failed to assure compliance with regulatory requirements. Review of the regulations 922 KAR 2:90, 922 KAR 2:110, 922 KAR 2:120 presented at the time of survey revealed the regulations were no longer current as they were dated 10/3/11.

245 - Regulatory Compliance/Staff in Charge

 - 4. An address check of the Sex Offender Registry; and
 - (c) Not be left alone in the presence of a child until copies of the background checks in accordance with paragraph (b) of this subsection have been received by the licensee.

305 - Background checks/discharged

- (6) Upon completion of background checks described in subsection (4)(b) of this section, a licensee shall discharge immediately:
 - (a) An individual whose name is listed on the central registry established by 922 KAR 1:470;
 - (b) An individual who has been convicted of, or has entered an Alford plea or a plea of guilty to, a crime in accordance with KRS 17.165;
 - (c) An individual who is confirmed by an address check of the Sex Offender Registry and supporting documentation as a registered sex offender;
 - (d) An individual who has been convicted of, or entered an Alford plea or plea of guilty to, a drug-related felony, and five (5) years has not elapsed since the person was fully discharged from imprisonment, probation, or parole;
 - (e) A director who has been convicted of, or entered an Alford plea or a plea of guilty to, a felony offense involving fraud, embezzlement, theft, or forgery; and
 - (f) An individual who has been convicted of, or has entered an Alford plea or a plea of guilty to, an offense under a criminal statute of the United States or of another state similar to an offense specified in this subsection.
- (7) An individual who has been convicted of, or entered an Alford plea or a plea of guilty to, a nonviolent felony or misdemeanor not specified in this section shall be handled on a case-by-case basis by the licensee with consideration given to the:
 - (a) Nature of the offense;
 - (b) Length of time that has elapsed since the event; and
 - (c) Individual's life experiences after conviction, Alford plea, or guilty plea.

315 - Educational Requirements

During further interview with owner/director, she acknowledged the center failed to present a file for this child at the time of survey.

Continued review of children's files revealed the written records for children enrolled 1/3/14, 4/28/14, and 7/17/15 failed to contain preferred hospital information. Further review of children's files revealed the written record for a child enrolled 5/15/14 failed to contain family physician and preferred hospital information.
