General: Based on Review of Documentation, a staff member hired on 8/28/15 did not have a criminal records check completed on or before her hire date. The staff member's criminal record check was completed on 9/18/15. This staff member also lives in Ohio, and did not have an out of state criminal records check completed nor evidence that an out of state criminal records check had been requested. The director informed DRCC surveyor she was unaware this was necessary.
