The staff person in charge stated the facility provides milk for children who do not bring milk to drink and supplements any components missing from a child's lunch. The children were observed eating lunch at the time of the survey. It was found that some of the children brought water to drink. Milk was not served to those children who had not brought milk to drink.
