The check shall indicate that the adult has not been convicted of, or has not entered an Alford plea or a plea of guilty to, an offense under a criminal statute of the United States or of another state similar to an offense specified in subparagraph 1 of this paragraph; and
 - 4. Copy of negative tuberculin results or a health professional's statement documenting that the adult is free of tuberculosis. Every two (2) years, the adult shall provide negative tuberculin results or health professional's statement documenting that the adult is free of tuberculosis.
- (b) An address check of the Sex Offender Registry conducted on behalf of the applicant for a Type II child-care center and supporting documentation shall indicate that no individual residing in the household is a registered sex offender.

Findings:

General: Based on Review of Documentation, and interview, the child care center director failed to assure compliance with regulatory requirements. Review of employee records revealed no documented evidence of completed professional development plans for child care center staff. Exit interview with the child care center director revealed the professional development plans had not been completed. Further interview with the child care center director revealed acknowledgement of the deficiency.

255 - Staff Meeting**In Compliance****922 KAR 2:110. Section 4. Director Requirements and Responsibilities.**

- (1) Effective with the adoption of this administrative regulation, a director shall:
- (i) Conduct, manage, and document in writing staff meetings;

Findings:

General: Based on Review of Documentation, and interview, the child care center director failed to assure compliance with regulatory requirements. Review of employee records revealed no documented evidence of completed Annual Evaluations for all staff reviewed. Exit interview with the child care center director revealed the evaluations had not been completed. Further interview with the child care center director revealed acknowledgement of the deficiency.

Findings:

General: Based on Review of Documentation, and interview, the child care center director failed to assure compliance with regulatory requirements. Review of employee records revealed altered/falsified Tuberculosis Screening results for the child care center director. Review of the documents indicated that she completed the exam on 08/10/12 and 08/20/14. The document signatures and dates as well as the employees name were exact duplicates. Exit interview with the child care center director revealed the document had been altered/falsified on purpose. The director stated, with the Executive Director present, she altered the document filed in the employee record, dated 8/20/14.

Additional review of employee records revealed the High School Equivalency Diploma for the employee with a hire date of 10/23/15, was altered by cut and pasted name of the employee. Exit interview with the child care center director revealed the document had been altered/falsified by the employee. Further interview with the child care center director revealed acknowledgement of the deficiency.

285 - Parental/Family Involvement Activity

Findings:

General: Based on Review of Documentation, and interview, the child care center failed to maintain employee records in accordance with regulatory requirements. Review of employee records revealed the child care center director failed to obtain the Criminal Records Background and Child Abuse/Neglect check for an employee with a hire date of 04/03/15. Exit interview with the child care center director revealed she did not think the employee needed the background checks because the employee does not work directly with children. Further interview with the child care center director revealed acknowledgement of the deficiency.

305 - Background checks/discharged

 - (e) A director who has been convicted of, or entered an Alford plea or a plea of guilty to, a felony offense involving fraud, embezzlement, theft, or forgery; and**
 - (f) An individual who has been convicted of, or has entered an Alford plea or a plea of guilty to, an offense under a criminal statute of the United States or of another state similar to an offense specified in this subsection.**
- (7) An individual who has been convicted of, or entered an Alford plea or a plea of guilty to, a nonviolent felony or misdemeanor not specified in this section shall be handled on a case-by-case basis by the licensee with consideration given to the:**
 - (a) Nature of the offense;**

(i) The individual resided outside the state of Kentucky in the last five (5) years; and
(ii) No criminal records check has been completed for the individual's previous state of residence; and
d. An address check of the Sex Offender Registry;

315 - Educational Requirements

(1) Child-care center staff:
(a) Hired after January 1, 2009, who have supervisory power over a minor and are not enrolled in secondary education, shall have a:
1. High school diploma;
2. GED or qualifying documentation from a comparable educational entity; or
3. Commonwealth Child Care Credential as described in 922 KAR 2:250;

Findings:

General: Based on Review of Documentation, and interview, the child care center failed to maintain employee records in accordance with regulatory requirements. Review of employee records revealed no documented evidence of education for child care center employees with a hire date of 02/02/15 and 10/23/15. The employee with a hire date of 10/23/15 submitted an altered/falsified High School Equivalency Diploma. Exit interview with the child care center director revealed acknowledgement of the deficiency.

320 - TB Verification

(b) Shall provide, prior to employment and every two (2) years thereafter:
1. A statement from a health professional that the individual is free of active tuberculosis; or

Findings:

General: Based on Review of Documentation, and interview, the child care center failed to maintain employee records in accordance with regulatory requirements. Review of employee records revealed no documented evidence of a health professional's statement or date of negative Tuberculin skin test results to determine compliance for employees with a hire date of 07/28/15 and 06/12/03. Employee with the hire date of 06/12/03 submitted an altered/falsified Tuberculosis Screening result as proof of completion. Review of the documents indicated that she completed the exam on 08/10/12 and 08/20/14. The document signatures and dates as well as the employees name were exact duplicates. Exit interview with the child care center director revealed the document had been altered/falsified on purpose. The director admitted, in Executive Director's presence, that she altered the document filed in the employee record, dated 8/20/14.

In addition, further review of employee records and the Early Care and Education Training Records Information System (ECE-TRIS) Website revealed no documented evidence that an employee with hire date of 10/27/14 completed Orientation training. Exit interview with the child care center director revealed acknowledgement of the deficiency.
