**Due to the current declared public health emergency caused by the Novel Coronavirus Disease (COVID-19), licensed child care centers must operate under Centers for Disease Control and Prevention and public health guidelines, as mandated by 922 KAR 2:415E, to prevent the spread of COVID-19.**

**Findings:**

General: Based on review of documentation and interview, the center failed to assure compliance with 922 KAR 2:415E. Two (2) staff members hired 03/19/18 and 04/03/17, failed to complete the mandatory training prior to the center reopening.
