## Findings:

General: Based on Observation, this regulatory requirement was not met. Upon arrival (2:33PM) the surveyor observed two (2) staff caring for thirty-nine (39) children (age range 6 - 12 yrs old) in the cafeteria. One (1) staff person (hire date: 9/28/14) identified her group as first and second graders and stated that she had twenty-two (22) children present. The other staff person (hire date: 7/15/19) identified her group as third, fourth and fifth graders and stated that she had seventeen (17) children present. The surveyor observed these two (2) groups function independantly throughout the entire visit (2:33PM - 4:00PM) by rotating in and out of the cafeteria. Since the staff person with a 9/28/14 hire date had six (6) and seven (7) year old children in her group, the minimum staff to child ratio would need to be one (1) staff person for fifteen (15) children. The facility exceeded the staff/child ratio by seven (7) children.



General: Based on Review of Documentation and interview, this regulatory requirement was not met. The facility did not have written safety procedures for transporting a child, loading/unloading a child and providing adequate supervision of a child during transportation. The staff person in charge stated the children go on field trips during the summer months. A review of the field trip documentation provided during the visit found that the children participated in approximately twelve (12) trips during the months of June and July 2014. ## Findings:

General: Based on Review of Documentation, this regulatory requirement was not met. The staff person in charge stated during interview that they do not have a specific list of names of children that participated in each field trip during summer 2014 and indicated that the facility attendance records are used during each field trip to keep track of the children present on each trip. The surveyor compared the facility attendance records to the field trip permission slips signed by the parents for two (2) of the field trip dates (6/19/14 and 6/24/14) and found that the number of children signed in on the facility attendance sheet did not match the number of permission slips obtained on these specific dates. On 6/19/15 nineteen (19) children were identified as being present on the facility attendance sheet; however, only fifteen (15) field trip permission slips had been obtained for the trip to Juniper Hill pool. One 6/24/15 seventeen (17) children were identified as being present on the facility attendance sheet; however, only sixteen (16) field trip permission slips had been obtained for the trip to Louisville Zoo.
