4. Copy of negative tuberculin results or a health professional's statement documenting that the adult is free of tuberculosis. Every two (2) years, the adult shall provide negative tuberculin results or health professional's statement documenting that the adult is free of tuberculosis. (b) An address check of the Sex Offender Registry conducted on behalf of the applicant for a Type II child-care center and supporting documentation shall indicate that no individual residing in the household is a registered sex offender.

General: Based on Review of Documentation and interview, this regulatory requirement was not met. A review of the facility's written documentation found that there was no procedure in place for reporting child abuse and/or neglect to the cabinet. The staff person in charge stated that she was not aware of this regulatory requirement.
