Findings:

General: Based on review of documentation, the child abuse and neglect check for a staff member (DOH: 7/10/12) was submitted for completion on 8/8/12, which was not within the time frame required by 922 KAR 1:470. Also, the criminal records check was submitted for completion on 7/26/12, which was not within the time frame required by KRS 199.896.

305 - Background checks/discharged

General: Based on review of documentation, two (2) staff members (DOH: 7/1/12 and 7/10/12) completed orientation on 3/4/13, which was not within the first three (3) months of employment as required.
