General: Based on observation and interview, the surveyor found electrical wires from the CD player dangling down within reach of the children in the Busy Bees classroom.

During interview, staff stated the CD player will be placed where the wires are inaccessible

Findings:

General: Based on review of presented documentation and ECE TRIS records, the surveyor found:

- 1. Verification of only ten and one-half hours (10 ½) of early care and education annual training was found for a staff (DOH: 08/14/18).
- 2. Verification of only thirteen (13) hours of early care and education annual training was found for a staff (DOH: 10/01/18).
- 3. Verification of only thirteen (13) hours of early care and education annual training was found for a staff (DOH: 07/19/17).

480 - Infant/Toddler Combined with Older Children

- (2) Except in accordance with subsection (3) of this section or Section 2(2)(c) of this administrative regulation, an infant or toddler under twentyfour (24) months of age shall not participate in an activity with an older child for no more than one (1) hour per day.
- (3) If a toddler is developmentally appropriate for a transition to a preschool age group, a toddler may participate in an activity with an older child for more than one (1) hour per day if:
- (a) Space for the toddler is available in the preschool-age group;
- (b) The staff-to-child ratios and group sizes are maintained based on the age of the youngest child:

Findings:

General: Based on observation and interview, the surveyor found that two-year-old children were combined with children that are one and one half (1½) years old. Upon completion of the survey, the two-year-old children were still combined with the younger children.

Staff confirmed during interview that the two-year-old children were combined with the younger children for more than one (1) hour. Staff stated they were not aware that one and one half year old (1 1/2) children could not be combined with two (2) year olds.

- (7) The following shall be inaccessible to a child in care:
- (a) Toxic cleaning supplies, poisons, and insecticides;
- (b) Matches, cigarettes, lighters, and flammable liquids; and

Findings:

General: Based on observation and interview, the surveyor found the following:

- 1. There were two (2) tubes of hand lotion located on a desk by the cubbies in the Busy Bees Classroom; therefore, the tubes of lotion were accessible to the children. The tubes were labeled "Keep Out of Reach of Children."
- 2. There was one (1) liquid soap "Intimate Naturals" located on the sink in the Jungle Cubs Classroom; therefore, the liquid soap was accessible to the children. The soap was labeled "Keep Out of Reach of Children."

560 - Building Requirements **Not In Compliance**

922 KAR 2:120. Section 4. Premises Requirements.

- (5) The building shall be constructed to ensure the:

Findings:

General: Based on observation, the surveyor found that eighteen (18) steps, located near the Preschool Classroom, were not protected, as the classroom door was open; therefore, the children had access to the stairs.

Based on observation, the surveyor found a round heater located in the Preschool classroom that was unprotected; therefore, it was accessible to the children.

During interview, staff stated that the door to the classroom is usually closed. Staff also stated that they were not aware that the heater needed to be shielded from the children.

General: Based on review of presented documentation and interview, the surveyor found the following:

- 1. A child's (DOE: 10/02/18) enrollment information did not contain the general health status and medical history.
- 2. A child's (DOE: 09/23/19) enrollment information did not contain the general health status and medical history.
- 3. A child's (DOE: 09/04/18) enrollment information did not contain the general health status and medical history.

During interview, staff stated that they would have the parents complete the enrollment forms for the children.
