General: Based on Review of Documentation, two (2) caregivers hired on 7/30/18 and 7/18/18, each did not have TB documentation on file.

922 KAR 2:090. Section 11. Staff Requirements.

- (16) In accordance with KRS 199.896(15) and (16), a staff person with supervisory authority over a child shall complete the following:
- (a) Six (6) hours of cabinet-approved orientation within the first three (3) months of employment;
- (b) Nine (9) hours of cabinet-approved early care and education training within the first year of employment, including one and one-half (1 ½) hours of cabinet-approved pediatric abusive head trauma training; and
- (c) Fifteen (15) hours of cabinet-approved early care and education training during each subsequent year of employment, including one and one-half (1 ½) hours of cabinet-approved pediatric abusive head trauma training completed once every five (5) years.

Findings:

General: Based on Review of Documentation, a caregiver hired on 8/9/17, lacked three (3) hours of training. A caregiver hired on 9/20/17, lacked three (3) hours of training. Two (2) caregivers hired on 2/1/16, and 8/9/16, lacked nine (9) hours of training. A caregiver hired on 1/22/13, lacked six (6) hours of training. Two (2) caregivers hired on 2/1/16 and 9/25/17, had not completed Pediatric Abusive Head Trauma Training. Also, a caregiver hired on 8/1/16, completed the Pediatric Abusive Head Trauma Training on 9/24/18.

General: Based on Observation, flaky, brown plaster was around a ceiling vent, in the hallway, across from room #11.

922 KAR 2:120. Section 10. Toilet, Diapering, and Toiletry Requirements.

- (3) A sink shall be:
- (a) Located in or immediately adjacent to toilet rooms;
- (b) Equipped with hot and cold running water that allows for hand washing;
- (c) Equipped with hot water at a minimum temperature of ninety (90) degrees Fahrenheit and a maximum of 120 degrees Fahrenheit;
- (d) Equipped with liquid soap;
- (e) Equipped with hand-drying blower or single use disposable hand drying material;

Findings:

General: Based on Observation, the hot water registered eighty-two (82) degrees Fahrenheit at a sink, in the restroom of room #6. The hot water registered one hundred thirty-seven (137) degrees Fahrenheit at one sink and registered one hundred forty (140) degrees Fahrenheit at a second sink in the boys' restroom. Also, the hot water registered one hundred thirty-seven (137) degrees Fahrenheit at one sink and registered one hundred forty (140) degrees Fahrenheit at a second sink in the girls' restroom.

General: Based on Observation, a caregiver hired on 9/6/12, did not wash her hands prior to putting on gloves before a diaper change in room #2.

General: Based on Observation, two (2) cribs were placed next to each other. Also, two (2) cribs were placed four (4) inches apart in room #4.

Findings

General: Based on Observation and review of documentation, six (6) children were present, but only five (5) children had a documented arrival time in room #2. Nine (9) children were present, but only seven (7) children had a documented arrival time in room #3. Ten (10) children were present, but only nine (9) children had a documented arrival time in room #7. Twelve (12) children were present, but only eleven (11) children had a documented arrival time in room #9. Twelve (12) children were present, but only eight (8) children had a documented arrival time in room #11. Also, eleven (11) children had a documented arrival time, but ten (10) children were present. Therefore, a child did not document their departure time in room #10.
