General: Based on Observation, staff hired 5/18/18, did not have TB documentation on file.



410 - Training Not In Compliance

922 KAR 2:090. Section 11. Staff Requirements.

- (16) In accordance with KRS 199.896(15) and (16), a staff person with supervisory authority over a child shall complete the following:
- (a) Six (6) hours of cabinet-approved orientation within the first three (3) months of employment;
- (b) Nine (9) hours of cabinet-approved early care and education training within the first year of employment, including one and one-half (1 ½) hours of cabinet-approved pediatric abusive head trauma training; and
- (c) Fifteen (15) hours of cabinet-approved early care and education training during each subsequent year of employment, including one and one-half (1 ½) hours of cabinet-approved pediatric abusive head trauma training completed once every five (5) years.

General: Based on Review of Documentation, two (2) staff, each hired on 7/26/18 and 6/14/18, had not completed six (6) hours of orientation training within the first three (3) months. Staff hired 10/10/17, had not completed one and a half (1 1/2) hours of pediatric abusive head trauma. Staff hired 12/5/01, completed eight (8) hours of training.
