Provided with adequate supervision at all times by a qualified staff person who ensures the child is:</p> <p>a. Within scope of vision and range of voice; or</p> <p>b. For a school-age child, within scope of vision or range of voice;</p> <p>Findings:</p> <p>General: Based on observation, interview and review of documentation, the child care center failed to maintain adequate supervision in accordance with regulatory requirements. Video footage review revealed that on 03/11/2019, two (2) employees were seated at a table with eight (8) children, while two (2) children were crouched down on the front side of a bookcase, which was out of line of sight. Therefore, the staff could not see the activity going on in front of the bookcase. Interview with staff revealed the two (2) children engaged in inappropriate explorative behavior.</p> | |

Director Requirements and Responsibilities.</p> <p>(1) A director shall:</p> <p>(I) Assure the health, safety, and comfort of each child;</p> <p>Findings:</p> <p>General: Based on observation, interview and review of documentation, the child care center director failed to assure compliance with regulatory requirements regarding the health, safety, and comfort of a child. Review of video documentation revealed a three-year-old child was observed standing in front of a bookcase, observing two (2) other children engage in inappropriate behavior. Interview with the staff revealed a child was lying face down on the bottom shelf with his buttocks exposed. Therefore subjecting the other children to witnessing inappropriate behavior of others.</p> | |
