#### Findings:

General: Based on Review of Documentation, staff hired on 02/09/16 did not have documentation showing that a Child Abuse and Neglect Check had been submitted. Staff hired on 09/26/15 and 08/24/15 did not have a criminal records check on file. None of the staff members were alone with children. Staff person in charge stated that she would get the necessary paperwork completed. Staff member hired on 08/13/15 has lived in New Jersey within the past five (5) years. The out of state background check that was completed on that staff person does not list the results of the background check.
