(1) A child care provider shall maintain the employment or residential status of each child care staff member who has submitted to a fingerprint-based criminal background check by reporting the status using the NBCP Web-based system.

Findings:

General: Based on review of documentation and interview, the child care center failed to comply with background checks in accordance with regulatory requirements. Review of the KARES report revealed an individual who was listed under current employees and was determined to be eligible for employment on 1/29/19. Interview with the director revealed that the aforementioned individual was no longer employed with the child care center.

General: Based on observation, the child care center failed to maintain the premises in accordance with regulatory requirements. There were several empty plastic bags located on the bottom shelf of the changing table located in the Infant Room at the time of the survey.

General: Based on observation, the child care center failed to maintain the premises in accordance with regulatory requirements. There was only one (1) of the two (2) lights working in the Kitchen causing the Kitchen to be very dimly lit at the time of the survey.

Findings:

General: Based on observation, the child care center failed to maintain the premises in accordance with regulatory requirements.

- 1) There were several water stains in the ceiling at the entrance to the Two-Year-Old Room.
- 2) There was yellow peeling paint located under the cubbies in the One-Year-Old Room.
- 3) There was peeling blue paint located under the calendar in the Preschool Room.

General: Based on observation, the child care center failed to maintain an outdoor play area in accordance with regulatory requirements. The slide located in the outdoor play area did not have a protective surface located at the bottom/end of the slide.

Findings:

General: Based on observation, the child care center failed to maintain equipment in accordance with regulatory requirements.

- 1) The red and green large pillows located in the reading area in the Two-Year-Old Room were stained.
- 2) The large yellow pillow located in the reading area in the One-Year-Old Room was stained.
- 3) The faucet attached to the sink located in the Infant Room was not working properly at the time of the survey. The faucet had water coming out of the handle when turned on and a white bucket was located under the sink to catch the leaking water.

Findings:

General: Based on observation and interview, the child care center failed to maintain equipment in accordance with regulatory requirements.

- 1) All the cabinet doors were missing from the brown toy kitchen located in the Two-Year-Old Room at the time of the survey.
- 2) All the doors were missing from the beige toy kitchen located in the One-Year-Old Room.

Interview with the director revealed that they still had the doors to the equipment but had removed them once the children had started to break them.

General: Based on observation, the child care center failed to maintain food service in accordance with regulatory requirements. The white mini-fridge located in the Infant Room had an indicating thermometer reading of forty-six (46) degrees Fahrenheit at the time of the survey.

Findings:

General: Based on review of documentation and interview, the child care center failed to maintain children's records in accordance with regulatory requirements. Review of the presented children's records revealed a child with enrollment date 7/24/18 whose file did not contain the name of each person who is designated in writing to pick-up the child. Upon request, the director did not present the documentation for the aforementioned child at the time of the survey.
