General: Based on review of documentation, staff hired on 01/28/2019 did not have required proof of education on file.

- 1. A statement from a health professional that the individual is free of active tuberculosis; or

General: Based on review of documentation, staff hired on 1/16/2019 and 01/28/2019 did not have proof of negative TB results or a physician's statement showing they are free from TB.

General: Based on review of documentation, staff with hire date of 06/11/2018 did not have required orientation training on file or on TRIS. Staff with hire dates of 03/08/2009, 03/12/2009, 06/29/2016, 06/01/2016 did not have the required 15 hours of training on file or on TRIS.

General: Based on observation, the preschool room combined children ages 2-4. No child had a transition plan on file.

(9) Floors, walls, and ceilings shall be smooth, in good repair, and constructed to be easily cleaned.

Findings:

General: Based on observation, the walls in the entire facility showed tears, scratches and debris. The carpet in the infant room was soiled in multiple areas.

640 - Toilet Room Not In Compliance

922 KAR 2:120. Section 10. Toilet, Diapering, and Toiletry Requirements.

- (2) A toilet room shall:
- (a) 1. Be provided for each gender; or
- 2. A plan shall be implemented to use the same toilet room at separate times;
- (b) Have a supply of toilet paper; and
- (c) Be cleaned and disinfected daily.

Findings:

General: Based on observation, the girls' bathroom did not have any paper towels available. The girls' and boys' bathrooms had excessive built up dirt on the floors and there was built up dirt around the sink area. Under the sink in the girls' bathroom was an area of tile that was turned upwards and exposing the floor beneath it,

General: Based on observation, a toilet in the girls' bathroom had feces stuck to the sides of the toilet bowl. In the boys' bathroom there was feces stuck on the toilet seat.

General: Based on observation, the diaper changing area was a counter top next to a sink that also contained cups and food. The diaper pad was just set aside when not being used and when not used for diapering, that space was used for food, supplies, etc.

- a. An epinephrine auto-injector shall be inaccessible to a child;
- b. A child-care center shall have at least one (1) person onsite who has received training on the administration of an epinephrine auto-injector if the child-care center maintains an epinephrine auto-injector;
- c. A child-care center shall seek emergency medical care for a child if an auto-injector is administered to the child; and
- d. A child-care center shall report to the child's parent and the cabinet in accordance with 922 KAR 2:090, Section 12(1)(b) if an epinephrine auto-injector is administered to a child; or
- 4. An emergency or rescue medication for a child in care, such as medication to respond to diabetic or asthmatic condition, as prescribed by the child's physician. Emergency or rescue medication shall be inaccessible to a child in care;
- (b) Kept in the original bottle; and
- (c) Properly labeled.
- (7) Medication shall not be given to a child if the medication's expiration date has passed.

Findings:

General: Based on observation, non labeled eye drops and lotion were in the first aid kit.
