Findings:

Preschool: Based on Observation, upon arrival to the classroom there were nineteen (19) children age four (4) years old and one (1) staff person in the room. A few minutes later an additional staff person entered the room. The staff to child ratio with the age of the youngest child being four (4) years old is one (1) staff person for fourteen (14) children. This means that the staff to child ratio was over by five (5) children. Later during the survey the same staff person left the room to get milk from the kitchen down the hall. This left one (1) staff person with nineteen (19) four year olds.

An interview with the staff person in charge found that all four (4) staff had completed six (6) hours of KET training but have not received their certificates verifying the training has been completed.
