(a) Posted in writing in a conspicuous location with each age group and followed;

(d) Be designed to guard against entrapment or situations that may cause strangulation.

General: Based on observation, this regulatory requirement was not met. The swing set on the playground contained areas of chipped paint on the blue metal poles. In some of the areas, rust was exposed on the metal poles where the paint was chipped off of the surface.
