Observation of the Cafeteria on 9/16/15 at 2:44pm revealed a school-age child walked out of the cafeteria by himself, went into the hallway, and was out of the scope of vision and range of voice of the site director for approximately thirty (30) seconds.

Observation of the Cafeteria on 9/16/15 revealed the site director was the sole caregiver of at least thirty five (35) school-age children from 2:38pm-2:45pm. Continued observation of the Cafeteria revealed the site director was the sole caregiver of at least forty-nine (49) school-age children from 2:45pm-3:03pm. Observation of the AFR Room on 9/16/15 at 3:08pm revealed two (2) staff members supervising forty (40) children ages four-years-old to seven-years-old. Interview with site director revealed he was aware the center was out of ratio on the date of the survey.
