922 KAR 2:090. Section 9. Records.

(1) A child-care center shall maintain:

(h) A written record of quarterly practiced earthquake drills and tornado drills detailing the date, time, and children who participated in accordance with 922 KAR 2:120, Section 3;

(i) A written record of practiced fire drills conducted monthly detailing the date, time, and children who participated in accordance with 922 KAR 2:120, Section 3;

Findings:

General: Based on review of documentation, the surveyor found the following:

- (1.) Fire drills were not conducted or documented for the following months in 2020: July, August, September, October, November, and December.
- (2.) A fire drill for January 2021 was not conducted or documented.
- (3.) The quarterly earthquake drills were not conducted or documented from July 2020 through December 2020.
- (4.) The quarterly tornado drills were not conducted or documented from July 2020 through December 2020.

Staff confirmed through interview that the drills were not conducted due to safety concerns regarding COVID.
